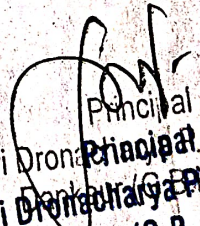

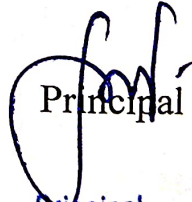

MINUTES OF MEETING

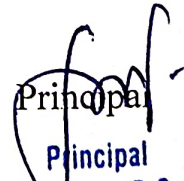

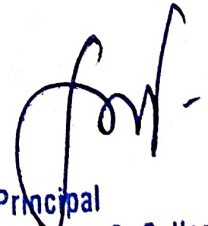
ANTI-WOMEN HARASSMENT COMMITTEE

ACTION TAKEN REPORT

The Anti-Women Harassment Committee convened a meeting on November 11, 2024, to address the safety and security of female students, faculty members, and non-teaching staff at SDPG College. The following actions were implemented:

1. The principal suggested to conduct a workshop on Cyber Crime and Cyber security alert.
2. The co-ordinator of the committee decided to introduce all the female students and faculty members especially non-teaching staff provide basic knowledge of cyber crime.
3. The co-ordinator also decided to give them information related to block unauthorized trafficking, encrypting a secure internet connection and network segmentation so that they could be safed from any kind of digital arrest and syber crime.
4. The principal orderd to invite a senior police officer for giving complete information of General Data Protection Regulation and Health Insurance Portability and Accountablity Act.
